

Privacy Policy

Seahawk Marine Foods Limited is responsible for this web-site and is the data controller. We take your data protection very seriously. This Privacy Policy is designed to explain how we use any personal information we collect about you when you use this website. We may update this policy from time to time, so please ensure you regularly check back to review it.

What information do we collect about you?

As a general policy, we have designed our web-site to minimise the amount of personal information collected. We collect information about you:

- By means of CCTV to monitor activities on certain premises and your image and vehicle registration may potentially be stored for a period of weeks.

This information is provided by you. We also collect information about your use of our site through the use of cookies.

How will we use the information we collect?

Our use of the data provided by you will be processed for legitimate business reasons:

- To respond to our enquiry and to provide our New Account Form to engage with us as a customer. Should you become a customer or supplier we will use your account details to manage your account with us and to provide you with update communications via email.
- To assess your suitability for the vacancy you have applied for.
- To send you information that you request from us relating to our products and services.

We will store your data only as long as is required to process your enquiry. We will store job applications for the duration of the recruitment process, and securely destroy your details if you are unsuccessful. If you become a customer or supplier to Seahawk Marine Foods Ltd, we will securely store your details for as long as you remain a customer of or supplier to the company.

Access to your information and correction

You have several rights in relation to your personal data:

- The right to contact the ICO and the right to access your information.

Cookies

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information. We will not associate any data gathered from this site with any Personally Identifiable Information from any source, unless you explicitly submit that information via a fill-in form on our website.
